

The Benefit System for .sk Registrars

Conditions:

1. The Benefit System for .sk Registrars (hereinafter as “Benefit System”) is for all Registrars.
2. Upon meeting certain goals, the Benefit System grants favourable conditions for the registration of Domains and related Domain services. This includes “org.sk” domain, while the discount prices are halved for “org.sk”.
3. For the purposes of the Benefit System,
 - 3.1 a New Domain shall be considered a Domain that is free/unregistered at the time of its registration;
 - 3.2 a Renewed Domain shall be considered a Domain with a renewed Registration Period.

Stable Discount:

4. Upon reaching at least 10 New Domains by a single Registrar in the given month, the Stable Discount grants a discount of 1 EUR excl. VAT (0.5 EUR excl. VAT for org.sk) for each New Domain the Registrar registers in the given month.

Dynamic Discount:

5. The Dynamic Discount depends on the size of the Registrar (i.e. the total number of Domains administered by the given Registrar) and reaching the goal in the given month. It applies under the following mechanism (the indicated prices are without VAT):

The number of Domains administered by the Registrar	Goal	
	Lower level (at least 10 Domains)	Higher level (at least 20 Domains)
<u>Tier 1</u> : 0–999 Domains	3% New Domains	6% New Domains
<u>Tier 2</u> : 1,000–19,999 Domains	1.5% New Domains	3% New Domains
<u>Tier 3</u> : 20,000–49,999 Domains	1% New Domains	2% New Domains
<u>Tier 4</u> : 50,000 and more Domains	0.75% New Domains	1.5% New Domains

Discount for New Domains	-1.5 EUR (-0.5 EUR) / New Domain (org.sk)	-3 EUR (-1.5 EUR) / New Domain (org.sk)
Discount for Renewed Domains	-0.1 EUR (-0.05 EUR) / Renewed Domain (org.sk)	-0.2 EUR (-0.1 EUR) / Renewed Domain (org.sk)

6. The goal shall be calculated as the per cent of the total number of Domains administered by the Registrar and always at the beginning of the calendar month. The goal shall not be affected by any change in the number of Domains administered by the Registrar during the calendar month, neither by switching to another category.
7. To reach the discount, the goal must be met in the given calendar month.
8. For each type of Discount, the Discount shall be only applied to the Domains that are secured using DNSSEC, i.e. Domains for which DNSSEC security occurred no later than the last day of the month in which they were registered or renewed.
9. Changing a Registrant shall not be considered a registration of the Domain.
10. SK-NIC reserves the right not to grant the Discount, while at the same time, the Registrar's entitlement shall cease, should
 - 10.1 SK-NIC withdraw from the Registrar Agreement with immediate effect under the Rules in force since 25th May 2018 or later;
 - 10.2 the Registrar fail to duly and within the maturity period pay the invoice issued under the Registrar Agreement.

The Benefit System is valid from 1st July 2021 to 31st December 2021. Updated on 15th August 2021, including change in clause 8, where since 1st September 2021, the condition applies to the Dynamic Discount only.
