



### Terms and Conditions for the Use of the Special Second-Level Domain org.sk

The "org.sk" domain is a domain designated for registration by non-for-profit entities from Slovakia.

#### 1 Introductory Provision

The provision of third-level domains registration under the "org.sk" domain is a special service under section 4.7.1 of the Terms and Conditions of Domain Name Service in .sk Top Level Domain (hereinafter the "Terms and Conditions") of the advanced type. The registration at the "org.sk" domain is available to all the Registrars after their accreditation for this activity under the section 10.2.7 of the Terms and Conditions.

#### 2 Basic Rules

- 2.1. The registration of third-level domains under the "org.sk" Domain and the actions related thereto are carried out in the same manner as the registration of and actions pertaining to Domains under the Terms and Conditions and are likewise governed by analogous conditions under the Terms and Conditions, including the conditions for the User, Registrant and Registrar, as well as the personal data protection under the Terms and Conditions. The above also concerns all the services provided for the Domains unless specially stated otherwise. The term "Domain" shall in such cases be considered equivalent to the term "third-level domain under the 'org.sk' Domain".
- 2.2. With regard to section 2.1 of the Terms and Conditions, the requirements concerning the User are supplemented: only such entity may become and be the Registrant of a third-level domain under the "org.sk" Domain that is a User under the Terms and Conditions and that
  - 2.2.1. has a seat or place of business in the Slovak Republic and
  - 2.2.2. is a legal entity which has not been established for the purpose of making profit and, simultaneously, it is
    - a) a civic association;
    - b) a foundation;
    - c) a non-investment fund; or
    - d) a non-for-profit organisation that provides services of general benefit ("n. o.").
- 2.3. Before the registration of of a third-level domain under the "org.sk" Domain by a User who requests the registration, the Registrar is obliged to request from the User the evidence or confirmation of facts meeting the conditions under the section 2.1 hereof (e.g. by means of a

sworn affidavit) or to perform a direct verification in the relevant official register. In addition, during registration, administration and actions related to the third-level domains under the "org.sk" Domain, the Registrar is obliged to adhere to all the rights, conditions and procedures under the Terms and Conditions.

- 2.4. The failure to meet any requirement under section 2.2 hereof shall give SK-NIC the right to act in accord with the sections 2.6 and 4.5.4 of the Terms and Conditions.
- 2.5. With respect to the registration of the third-level domain under the "org.sk" Domain, SK-NIC may likewise reasonably apply all the rights, conditions and procedures under the Terms and Conditions.
- 2.6. The registration of and any actions with third-level domains under the "org.sk" Domain represent a non-standard service and the relevant fees are provided in the Special Payment Conditions for Non-Standard Services, with the payment conditions governed by payment conditions under the Pricelist in accord with the Terms and Conditions.

## 3 Changes of the Terms and Conditions for the Use of the Special Second-Level Domain org.sk

- 3.1. SK-NIC may change these terms and conditions and all the related documents at any time. The current wording of these terms and conditions and all the related documents are published at the SK-NIC website.
- 3.2. Any addendum to, objection to, limitation of or deviation from these terms and conditions and/or related documents by a person other than SK-NIC are excluded.
- 3.3. Should the User not accept the change of these terms and conditions or related documents under the section 3.1 hereof, it shall have the right to make a written request for the termination of the registration periods of its third-level domains under the "org.sk" Domain, that being at the latest on the day before the day of such change coming into effect, and
  - 3.3.1. in such case SK-NIC shall have the right to withdraw from the relevant Agreements concerning the Domain, and the withdrawal shall come into effect by delivery thereto to this User,
  - 3.3.2. if the User is simultaneously a Registrar, such request shall also be understood as a request for the termination of this Registrar's accreditation for the third-level domains under the "org.sk" Domain; following the termination of the accreditation, SK-NIC shall reasonably apply section 9.16 of the Terms and Conditions on all the third-level domains under the "org.sk" Domain until then administered by this Registrar,
  - 3.3.3. if the User fails to do that in the stipulated period, it shall be considered that it has accepted such change by the day of effect thereof, understands the changed conditions or related documents and agrees to adhere to them in the full scope.
- 3.4. If the User does not accept the change under 12.1 of the Terms and Conditions, the procedure under 12.4 of the Terms and Conditions shall also be analogously applied to the third-level domains under the "org.sk" Domain.

# 4 Changes of the Terms and Conditions for the Use of the Special Second-Level Domain org.sk

- 4.1. Other language versions hereof are provided merely by way of facilitation of communication with foreign entities; the Slovak version is the only version that is legally binding and takes precedence in case of a dispute.
- 4.2. These terms and conditions are issued with force and effect starting as of 15.8.2021.
