

## **Promotion: Cheaper New Domains**

## Promotion conditions:

- 1. The Cheaper New Domains promotion is available to all Registrars.
- 2. The Cheaper New Domains promotion allows cheaper pricing within first year of the Domain registration period 7 EUR excluding VAT which shall be calculated as an unified special price instead of the standard price for Registrars stated on the Pricelist.
- 3. The special price is applied only
  - to a new Domain, i.e. a Domain that is free / unregistered at the time of its registration, and the time of registration must occur during the term of this promotion,
  - during the first TA status or Deactivated status of the new Domain if the new Domain changes its status to other than the one defined here, the eligibility for the special prices ceases to exist, i.e. standard price according to the Pricelist will be applied to this Domain; condition under this point is not considered after 31.8.2017.
- 4. Change of Registrant is not considered a new Domain registration.

This promotion runs from 1.9.2016 to 30.6.2021.



## Promotion: Achieve 100, Gain 100

## Promotion conditions:

- 1. Achieve 100, Gain 100 promotion is available to all Registrars.
- 2. The Achieve 100, Gain 100 promotion is used to reward Registrars for registering new Domains. For every 100 new Domains registered and secured by DNSSEC, the Registrar will receive a rebate in the amount of 100 EUR excluding TAX.
- 3. Eligible Domains for the purpose of this promotion
  - are only new Domains registered and paid for within the Cheaper New Domains promotion where the time of payment occurred within the period of the Achieve 100, Gain 100 duration, that means after the due date of the relevant invoice. Time of the payment means the receipt of the funds into the designated account of SK-NIC.
  - 3.2 A DNSSEC Secured Domain is a Domain where the DNSSEC Securities occurred no later than the last day of the month in which it was registered
  - 3.3 are not Domains that fail to meet the conditions according to point 3.1., e.g. Domains whose registration period is renewed, or were already registered etc.
- 4. The rebate is proceeded by SK-NIC issuing a credit note and up until 31.8.2017 by sending the appropriate funds to the Registrar's account. After 1.9.2017, the credit in the Registrar's account will increase by the amount of the rebate, while at the same time
  - 4.1 SK-NIC shall issue the credit note according to the current data kept in the records in relation to the Registrar contract of the Registrar,
  - 4.2 if the rebate amount is being sent to the Registrar's account, the Registrar shall notify SK-NIC of the bank account to be used for the receipt of the funds (Registrar's account),
  - 4.3 the credit note is issued on the first day of every month within this promotion period and on the first day of the month following the completion of this promotion, for the previous period during which the Registrar met the conditions according to point 2 and is entitled to a rebate,
  - 4.4 SK-NIC shall send the funds for all valid rebates within 14 days of the relevant credit note being issued.
- 5. In the event where more Registrars merge, their right to return of funds fuses as well.

- 6. SK-NIC reserves the right to not issue the rebate, which also terminates the relevant right of the Registrar, if
  - 6.1 the data in accordance with point 4.1 required to issue the credit note is false,
  - funds are due to be sent to the Registrar's account and the conditions in point 4.2 are not met by 31.8.2017,
  - 6.3 the Registrar contract termination in accordance with clause 15.3.1, 15.3.4 or 17.3 of the Terms and Conditions effective from 28.5.2015 or 1.1.2017 or later has occurred and the condition according to point 4.2 of this promotion or according to point 15.3.2 or 15.3.3 of the Terms and Conditions effective from 28.5.2015 or from 1.1.2017 or later was not met by that date, or if SK-NIC has withdrawn from the Registrar contract with immediate effect according to the Terms and Conditions effective from 1.9.2017,
  - 6.4 The Registrar has not properly paid an invoice issued pursuant to the appendix to the Registrar contract enabling the usage of symbol "mandatory payment" within its due time.
